    - 4. Revelation law; natural law; common law; positive law. Examples:
      - a. Discovery of various law codes that <u>predate</u>
        Moses: Ur-Nammu; Hammurabi;
        Egyptian law that Joseph was under
      - b. The understanding of the <u>patriarchs</u>: Job, Abraham Gen 18:17-21
      - c. The manner in which God speaks of His judgment of <u>people</u> Ezek 16:48-50
      - d. The manner in which He judges the <u>divine</u> council Psalm 82:1-4
    - 5. Election of Israel and the giving of the law the marriage covenant for living in the land Deut 32:9; Rom 9:4-5; Eph 2:11-18
    - 6. God judges people according to the law or revelation they have Rom 2:12-16; Rom 1:18-21; Acts 17:23-31
    - 7. Gentiles do not become Israel to be spared

## II. WHEN GOD DOES DO WHAT YOU DON'T WANT HIM TO DO

- A. The Mad Messenger the bigger sinner!
  - 1. He believes in Israeli <u>exceptionalism</u> they are the covenant people and these are the evil ones
  - 2. He knew what God would do if these repented and He did it. Jonah had already lodged a complaint!
  - 3. Had he carried out his responsibility hoping they would not repent? Or that they would and God would destroy them anyway because he had done what God wanted done?
- B. But He does not stop <u>praying</u>! Prays to die! (Sometimes when we want to prove our sincerity our memories get short and we use hyperbole to manipulate others)
- C. Moody, sullen, disappointed and <u>depressed</u> he waits for God to change His mind and totally misses the point (wants to die for the third time!)
- D. These people belonged to God and they had been on the wrong side of God and of life. Should they not have opportunity to repent and live? The prophet was more concerned about his comforts than he was people. How's your vision?
