## *WE APPROACH THE LORD*

### Call to Worship

*Those who are righteous, that is, conformed to God's Law, are here commanded to rejoice in the Lord, because, as the rest of this psalm makes clear, it is God who accomplishes this by His grace.*

## *WE ACKNOWLEDGE OUR SIN*

---

#### \* Reading from the Law

*This passage, known by the Jews as the "shema," is the central confession of Old Testament religion, and reveals several fundamental truths: the path to blessing through obedience to God's law, the oneness of God, and love as the essence of the law.*

#### **Deuteronomy 6:1–9** ESV

"Now this is the commandment—the statutes and the rules—that the LORD your God commanded me to teach you, that you may do them in the land to which you are going over, to possess it,<sup>2</sup> that you may fear the LORD your God, you and your son and your son's son, by keeping all his statutes and his commandments, which I command you, all the days of your life, and that your days may be long.<sup>3</sup> Hear therefore, O Israel, and be careful to do them, that it may go well with you, and that you may multiply greatly, as the LORD, the God of your fathers, has

promised you, in a land flowing with milk and honey.

<sup>4</sup>“Hear, O Israel: The LORD our God, the LORD is one. <sup>5</sup>You shall love the LORD your God with all your heart and with all your soul and with all your might. <sup>6</sup>And these words that I command you today shall be on your heart. <sup>7</sup>You shall teach them diligently to your children, and shall talk of them when you sit in your house, and when you walk by the way, and when you lie down, and when you rise. <sup>8</sup>You shall bind them as a sign on your hand, and they shall be as frontlets between your eyes. <sup>9</sup>You shall write them on the doorposts of your house and on your gates.

## Silent Confession of Sin

### Corporate Confession of Sin

*We pray now not only for mercy and forgiveness because of our violations of God's law, asking for deliverance from the enemy who accuses us (the Devil), but also for the enlightenment and stability that comes through instruction in that same law.*

## *WE REJOICE IN THE ASSURANCE OF FORGIVENESS*

---

### Assurance of Pardoning Grace

*We see here the centrality of the law in God's plan of salvation: it shows us our condemnation in sin, leads us to the Gospel through the Spirit, and is the goal towards which His grace leads us to give us blessing.*

**Romans 8:1–4** <sup>ESV</sup>

There is therefore now no condemnation for those who are in Christ Jesus. <sup>2</sup>For the law of the Spirit of life has set you free in Christ Jesus from the law of sin and death. <sup>3</sup>For God has done what the law, weakened by the flesh, could not do. By sending his own Son in the likeness of sinful flesh and for sin, he condemned sin in the flesh, <sup>4</sup>in order that the righteous requirement of the law might be fulfilled in us, who walk not according to the flesh but according to the Spirit.

Leader: This is the gospel.

**Congregation: Hallelujah!**

For those with conscientious convictions against the use of wine, however, we offer grape juice, which is contained in the inner circle of the communion trays. The cups containing wine are in the outer circles.*
