NO. Now you've got this guy in room 4 who got his second dose of vaccine on Tuesday, has been short of breath, okay? Now his BNP is elevated, D-Dimer elevated, ALT. All his liver enzymes are elevated. His PT, PT-INR is elevated.

DG. I'm gonna have to transfer you to another hospital. We don't have cardiologists here and what you're developing is like a congestive heart failure, okay? And that's not good. I don't know where this is coming from. On July 29<sup>th</sup>, you had the first COVID vaccine and August 19<sup>th</sup> you had the second. You know, you don't have COVID, okay, but you have

got a lot of symptoms, you know, and you're developing congestive heart failure.

He had the Pfizer vaccine at the end of July and he was due for his second dose, so this is essentially two to three weeks later. "Most likely cause of hypoxia unusual PE at this age, unclear etiology." They don't know why he got it.

NO. Because this is a 15 year old, normal weight, healthy child. No reason for him to have a blood clot.

Dr. McCullough (DM). Yeah, thanks for having me, Mike. It's great to be here.

MA. You referred to the biodistribution study, one of which I'm aware is out of Japan, and the mainstream vaccine industry claims that these spike protein nanoparticles do not circulate throughout the body but the studies show they do, I think there's another pharmacokinetic study as well that establishes that. What you just mentioned is huge. I mean, just based on that research alone, it seems like the FDA should pull the emergency authorization and say, "Wait a second, we need to study this in more depth. We can't inject people if this is circulating throughout the entire body." But they're not doing that, what's going on?

DM. The vaccines that Johnson & Johnson, Pfizer and Moderna have a very dangerous mechanism of action. We cannot have genetic substances circulating in our body in lipid nanoparticles or other forms of matrix nanoparticles and go to our brain. We can't do that. I mean, that cannot be allowed. It's a dangerous mechanism action. The Japanese did not trust Pfizer and when Pfizer said it stayed locally in the arm, Japan said, "We don't trust you. Show us where this goes." And there was a biodistribution study done of the nanoparticles, not the [unintelligible] but the nanoparticles, and they went everywhere. They did wash out of organs in a couple of days but they hyperconcentrated in the ovaries. In Europe, they didn't trust Moderna on fertility and they asked them what happens to fertility with Moderna. They did an animal study and Moderna dropped fertility. The FDA, Mike, told Pfizer, Moderna and J&J, no pregnant women, no women

of childbearing potential who cannot assure contraception. They did that for a reason, they knew the vaccine should not be used in young women. They knew that.

MA. And yet the vaccine is being promoted for pregnant women all across America today by the medical establishment, but just getting back to that study, as I recall, one of the other areas where the nanoparticles tended to cluster was in the adrenals. So now we're talking about a hormonal interference which could affect fertility, it could effect mental states, moods, it could effect so many things, right, in the body, unknown effects.

DM. Right, well, there have been nanoparticle studies, there was one from China published about eight years or so ago, that tested these nanoparticles and they asked where did they go and they made a brilliant, nice rainbow of all the organs where the nanoparticle shower and they did show that they go to the ovaries. So the point is in the adrenals, so the point is the FDA, Pfizer, Moderna, J&J, they knew or they should have known that these particles are going to hit these vital organs and then when they drop their genetic payload, then they're going to start producing the spike protein and damaging cells in those organs.

So it was not surprising when young women were ill-advised and took the vaccine, they started having problems with their periods. That was not unexpected. In a New England Journal Medicine paper of pregnancy, of women who took the vaccine, the authors concluded it was safe to give the vaccine in pregnancy. Now no woman carried the baby nine months because the vaccines haven't been around nine months but they looked at different windows of time and they divided all the pregnancy loss rates by the largest denominator possible so it was really false reporting. When we zeroed in on the first trimester and just divided by those who got the vaccine in the trimester, not those who got it later on, there was an 83% loss in fetal, in the babies.

So these vaccines are directly killing babies in the first trimester and it is absolutely atrocious, horrible, [unintelligible] right now is recommending that women, pregnant women take the COVID-19 vaccine. Pregnant women can breeze right through COVID-19. There has been some bad outcomes but it is very treatable with our drugs. We can even use hydroxychloroquine through pregnancy, we can use Prednisone and other drugs. No woman should ever take the risk with the COVID-19 vaccine during pregnancy. Period. The FDA, Pfizer, Moderna, didn't allow it in their clinical trials. It should not be allowed in practice today.

MA. Yeah, and that's, you're talking common sense medicine here but it seems like common sense has been thrown out the window, but I'm so glad you brought this up because it seems like beginning in about maybe six months and continuing on, we may see a collapse in birthrates and maybe ongoing infertility problems, but that brings up the obvious question: do you think that there is an infertility or long-term population reduction agenda? And many people believe that. Lots of my guests have discussed that. Is that something that you subscribe to or is it we don't have enough data yet to conclude that?

DM. You know, I can't, I've been so focusing on the medical response and taking care of my patients. I know others are working on, you know, people have called them conspiracy theories, you know, the rapper R. C. Rapper says, you know, it's not a conspiracy theory if it keeps coming true, and I'm not going to comment on conspiracy theories but if you were to ask me do you think these vaccines are going to have an impact on fertility, I think the answer is yes. We've already seen that in the Moderna application and now with the fetal loss data fairly calculated from the New England Journal of Medicine study, there's no doubt about it, pregnant women are going to lose their babies if they take the vaccine, and it's worse than that, once they've conceived and they're breastfeeding, we now have vignettes in the vaccine that according to that recording system where women take the vaccine, they generate the spike protein and we infer the spike protein goes through their milk and then kills the baby.

So these vaccines need to stay away from babies and mothers and women who are trying to conceive. I mean, there can't be a more clear message. You know, women are concerned about, you know, drinking half a glass of wine during pregnancy, how in the world can they take a shot of a wildly experimental, unproven, unsafe vaccine for the first time, how could they ever do it? It's almost as if Americans and doctors and everybody are just brainwashed together. They are brainwashed. They've been propagandized and they are blindly accepting something that they should just stay away from.

Christiane Northrup, MD (CN). We are now working with a whole group of people. You know, we call ourselves the Five Docs, right? So this is Lee Merrick, Larry Poleski, Sherri Tenpenny, me, Carrie Madej, and you probably had most of them on your program, and we began, what happened is Tiffany Holme who is a marketing expert with [millionsagainstmmandates.org](http://millionsagainstmmandates.org), one of her friends is the one who started collecting stories of, we're talking thousands and thousands of stories of women having menstrual irregularities, things like passing an entire decidua like the entire inside of the uterus just falling out and, you know, what would do that? I've never seen it in my career as an OB/GYN. Clots coming out of the vagina of a 16 month old baby girl. A six year old in the UK bleeding into her underwear after spending the weekend with newly vaccinated grandparents, and I don't want to use the word vaccinated, newly inoculated.

MA. Right, right.

CN. There is something that is clearly being transmitted and if you look at the Pfizer document from the very beginning, on page 67 it actually says, and this is the stuff for study participants, right, when this was brand new, and they say no male should be impregnating a woman for seven weeks, and no female should get pregnant for seven weeks, and they say right on there because of skin contact or contact with sexual fluid. So you have to ask yourself what did they know, what do they know that they're not telling us?

MA. Was this guidance document is saying is they shouldn't have this contact for those numbers of weeks after being vaccinated?

CN. That is correct, after having the shot. Yeah, yeah. And now we're injecting synthetic mRNA in several different ways, one in an adenovirus vector which gives you the DNA of some other species. So then you have to deal with that, so by the way, the J&J shot is probably the most dangerous. They're all dangerous. But now all of a sudden, okay, in 2020, early 2021, you fall out of a plane, the parachute doesn't open, that's a COVID death, but you drop dead the day after you've had one of these shots and that's a coincidence. It is the same playbook that we have been hearing for, well, since 1986 when the vaccine schedule of the CDC tripled because Congress passed an act that said you can put anything in there you want. You're not liable.

This is where you have to get out your tinfoil hat and say, "Listen, folks, this is a depopulation agenda." Why else would you suddenly, why would Pfizer suddenly want to have permission to give the shot to 12-15 year olds? What is that window? That's puberty. That's puberty. So we want to and we're getting disturbing reports from fertility clinics that the men who've had the shot now have sperm that will not swim, the women who've had the shots have eggs that will not develop into embryos.

The indoctrination about vaccines started long long ago. You, you know, we need to reach herd immunity. By the way, herd immunity is not a proven concept unless literally you are a herd and unless a certain percentage of the herd had the actual disease. So this, first of all, a vaccine does not give you normal immunity. It doesn't give you the immunity that you get from actually having the disease. Here's the thing, the mRNA does go in there and there's good science that it then gets destroyed by the body, here's the problem: through a process called transfection, the mRNA recipe does not, it goes through the ribosomes and it's not like I totally understand this but I do know from transfection in the daughter cells of the original cells, when the cells undergo mitosis, then the DNA will become affected not on the first round but later so that we do have evidence that it changes your DNA and then you become a factory for this synthetic protein antibody to the spike protein. There's two things, there's the antibody that your body is creating and then there's also the spike protein. As Sherri Tenpenny points out, there are 50 billion spike proteins in each of the shots.

When you look at global public health, it is a death cult. Isn't it true, I believe that Bill Gates cannot go to India because so many children got polio from the polio vaccines in India. We do know that. I just saw a patent for infertility from vaccines. Is it going to take a massive amount of people dying? We know what the mainstream will call that, they'll say, "Oh, it's a more virile variant." No, it isn't. No, it isn't. That mRNA is designed to make a spike protein that will attack the placenta. We have some case reports that women who've had the shot begin to have disintegration of the placenta so that it looks old and inflamed. So the very organ that supports the child is under attack.

I was talking with Sherri Tenpenny and we, this targeting of the age 12-15 with the Pfizer shot during puberty, you know, we are aghast.

Brittany Galvin (BG). Thank you, Stew. Thanks for having me.

SP. Of course. So first of all, just to clear this up, have you ever in your history ever had any autoimmune diseases?

BG. I have had an autoimmune disease. Yes, I have rheumatoid arthritis. I was diagnosed about four years ago and I have been in remission for a couple of years.

SP. Okay. Do you have other than the rheumatoid arthritis, do you have any other preexisting conditions prior to the shot?

BG. Nothing that I have experienced. No. Nothing. I have never had heart conditions. I've never had seizures. I've never had whatever they're calling it, neuropathy. I've never had any of this. This is actually my third trip to a hospital in the last two weeks. Since the second Moderna shot, I have been here three times. Once was the ambulance and the 911 phone call. The second one was after I was released, I came back to the ER due to [unintelligible] continuing. And this is now the third time that I've been here. So I have had and undergone a lot of tests. I have had every blood test you can think of. I have had every neuro test you can think of including, I think they call them EED or EEG, and the brain MRIs, I've had three CTs, three brain MRIs, MRIs of my lower back. I had a lumbar puncture so a spinal tap. I've had everything, everything you can think of.

So yesterday right before I was about to be released by the team because, once again, they were believing, you know, we're not just...I don't want to say believing, they weren't able to understand what was happening to me other than a diagnosis of pericarditis which is of the heart which, again, I've never had before, other than that they couldn't figure out what else was going on so they immediately would just say, you know, it's stress, anxiety. So they were about to release me and the neuro team walked in and when the neuro team walked in, everything changed. They had received some results from my puncture.

SP. Okay, and those results, the neuro team told you was it as a direct result of the injection, the Moderna shot....

BG. He did, he did.

SP. ...being called the vaccine.

BG. He did. He said it was from the Moderna shot. I'm not the first patient that this has happened to. A lot of doctors and nurses here actually have told me that they are seeing a lot of side-effects. A common response is that we see it with a lot of vaccines but I didn't hear that from my doctor but my doctor told me it's that this is something he's seen from the Moderna shot specifically. There was another young lady here recently that had the exact same thing.

But after my first injection, I did have some of what I'm, you know, explaining with my legs. So imagine walking through the room and you feel like you're walking through mud or through cement. So you can walk but you feel so unsteady and they're so heavy. My feet were so heavy and this was maybe four or five hours after the first does. I got the second one and I actually experienced nothing right away. The second one wasn't bad at all. I didn't even have the pain in the arm like I did the first one. It wasn't until 13 days after that I had what we now know was not a seizure but I had seized up, I completely seized up and fainted on the floor, couldn't walk, my head was tingly, my ears were hot. My head was pounding with pain, I mean, the most incredible pain you can think of and I ended up calling 911 and by the time the paramedics got there, my entire body was what I call seizing up. So originally the doctors thought I had a stroke or a seizure.

The reason I've gone so public with it is because I feel like it's the biggest mistake I've ever made. You know, I didn't listen to myself. I listened to the media and I listened to the shaming, and I listened to the commercials and the broadcasts saying that if you didn't have the vaccine, you had to sit in a certain spot. Call your pharmacist and ask questions. Start asking your doctors questions. Put the metal on your body yourself and see if it works because I guarantee it does. And just pay attention. Del Bigtree. I don't know that you've ever sent anyone down to the Tractor Supply to grab some horse paste and eat it, but what do you think of, you know, when you see that and you see Fauci saying there's no evidence that ivermectin works, what do you have to say about that, that thought?

Richard Bartlett, MD. ER Physician & General Practitioner. Okay, so there's an old saying: if his lips are moving, blank. I heard the same thing about budesonide. He said that it's just...he had an interview with Matthew McConaughey on the internet and he said to Matthew that, "Budesonide is just a placebo, Matthew. It doesn't really work."

Bartlett. Oxford University said the opposite. Oxford is the oldest university in the English speaking world since 1096, 72 Nobel Prize laureates. They say that he's wrong. Del Bigtree. When I watched that video, I imagined that these are really good men that really care about people. The patients that have been vaccinated have higher and get sick, have higher viral load titers or levels than the unvaccinated. That means that they're going to be sicker and Israeli hospitals are filled with vaccinated patients.

So whenever you evaluate any therapeutic, you have to, first of all, see if you need it, does it work, and is it safe? And in my opinion, in general there's no medical necessity for COVID-19 treatment, only in the high risk group which has a 7.5% death rate.

By the way, you saw they didn't give any facts, they didn't quote any studies, they just...it's rhetoric. It's propaganda.

Bigtree. Well, I'm going to assume this script is written probably by somebody in Hollywood, scripted it, brought it in, said this is what you should say, probably had some experts.

As we look forward, are you concerned that we may, I've said, made some fairly dramatic comments out there that when I look at ADE, when I look at the history of this vaccine with all of the animal trials, and I say to everybody all the animal trials, not some of them, all of them we're seeing this issue, it was a big enough problem that we watched Dr. Peter Hotez go before the Congress early last year and say there's this problem with immune enhancement that I think is going to be very difficult to get around, nobody seemed to care. We rushed into human trials. We rushed right out of those human trials to the population and now we have very highly regarded experts that are very concerned about ADE, that we may be seeing the beginning of this, high titers, high, you know, viral loads, a waning vaccine which was always the concern. Everybody that's worried about ADE, even though they'll admit they don't really know what causes it, the big concern is if you have sort of a drop in your neutralizing antibodies and what remain are maybe disease-enhancing antibodies. I've said I think that we may see one of the great human die-offs of all times because of this vaccine. Are you in, are you of that opinion or do you see it a different way?

Zelenko. I feel that we're on the verge of a genocide and I don't use that word lightly. I'm, my family was a victim of a genocide. In World War II, over 40 of my relatives were shot or buried alive in a place called Babi Yar outside of Kiev so I know what genocide is, I grew up with stories about it, so I don't use that word lightly. And I hope I'm wrong. I hope I'm ridiculed for the rest of my life because if I'm right and if the world experts are right, then what we're really looking at is a death rate, according to some opinions, of 90% of the vaccinated people. Now do I think it's going to be 90%? You know what, let's say it's only 10%. So think about it. There are 2 billion people already vaccinated, 10% of that is 200 million people. That's not enough?

Bigtree. It's huge. It's huge. I mean, as I said, that would be the largest human die-off that I know of.

Zelenko. Do you know what the death rate would be if every single human being on the planet got COVID-19 and they were not treated? It would be less than .5%, that works out to be 35 million people. Horrific. I would never advocate for 35 million people to die. However, if they're treated properly, you can reduce that number by 85% to 5 million people. So assuming every single human being on the planet got COVID-19 and we treated the high risk patients properly, we would have 5 million dead people out of 7 billion.

You know, I think Bill Gates is a sociopath. I think we're all suffering because he couldn't get a girlfriend in high school. But what he said in 2015 at a TED lecture, you know that, that the world population should be reduced by 15% because of global warming. Then last year, this same guy said that 7 billion people need to be vaccinated. This is all on film. So I'm going to ask you a simple question: why would I take a vaccine for my health advocated for and financed by someone who wants to reduce the world population?

Bigtree. I would not think that that would be the best person to take that advice from. I agree with you completely.

Zelenko. Right. So depending on what percentage you believe, Dr. Dolores Cahill is saying 90%, other doctors are saying 75% or 50%. I just told you if every single human being, 7 billion people got COVID and we treated people properly, the death rate would be 5 million people. Compare that to an estimate of, let's say, 10% of humanity, 700 million people.

Bigtree. Yeah. And we're talking about, you know, over time that cancers, the autoimmune diseases, all these and the quality of life that is going to be on the horizon. What in your mind when you think that through, when I think of that video with all of these Rabbis saying get your shot, do what's right, you know, and I think of all the politicians all around the world, Israel, America, you know, the UK, you name it, Australia, I don't think, I don't believe they're all in on some desire, maybe Bill Gates has a different agenda but these people are doing what they believe the experts told them to do, what will that moment be like when it sinks in on these Rabbis, when it sinks in on

these politicians that, "I led millions of people to their death"? If that ends up, and you know, and I pray with you that we're wrong, but when we look at the science, do you imagine what that will be like? Zelenko. So we're segregating into two groups. Because of the demoralization of the individual, because of the fear and the isolation, people have become sheep and the reality is there's many many more of us than them, and what we really need to say, I can't really say what I want to say, but I will say that, "No, I will not take your vaccine. I will rather lose my job or lose my position in school, not travel on an airplane, but you're not going to coerce me into taking a course of action that will limit my future. Bigtree. Very well put.

Zelenko. And the reality is that unfortunately there are going to be a lot of job vacancies. I wouldn't worry about finding a job.

Bigtree. Right. Yeah, it's true.

Zelenko. So you have to have, you have to value your life. You have to understand you're made in God's image, your soul is a part of God, and you have to sanctify it by staying alive and serving Him and not give into your fear and run to false gods. I think society is going to segregate itself into two groups. It's already happening.

Bigtree. Who wins?

Zelenko. God always wins.

I took it right off the CDC site for previous years before this pandemic took place and you're talking, you know, like 80,000 people or something like that died in 2017 from influenza and here we've got this COVID-19 supposedly if the 6% thing was right, killing 12,000, you know? But how come they didn't say anything in 2017 about 80,000 people dying?

Greg. You can see how these stack of lies, they're leading somewhere, they're leading to the shot basically, the substance that they want to put into people's bodies. All of this last year's theater leads to that. And another thing I forgot to mention too which you kind of brought up with the masks, is that they were propagating the lie that there was an asymptomatic spread of a virus which has never been proven medically but these are the lies that men like Fauci and the head of the CDC, Redfield, Jesuits, were propagating and then they were... So back in the day, only witches were using drugs so they found the parallel but it's really drug use and it goes right back to Satan and this is the work of the devil is getting people down this whole pharmaceutical pathway as opposed to trusting in God and their God-given immune systems. It's a complete counterfeit. It's just, it's sad that we've allowed it to get this out of hand in our country where we're sliding into medical tyranny.

Larry. Well, see, also just the political pressure where all these churches are shut down because of this pandemic, you can't even have a regular church service or, you know, in some of these countries they, like I think it happened in Germany or something like that, they broke in. I think that also happened in Canada where they break into a church service because they're not wearing masks and you've got guys in riot helmets and they've got bullet proof vests and they're coming in there, these little old ladies in the church service, you know, because they're not wearing a mask and they start forcing them to wear a mask. And I just see that as interference from the devil to interfere with a normal worship of God in the context that God has defined in the word of God.

Greg. It's sad that in Canada they don't have the Bill of Rights protections that we do here in America. They tried those tactics here early on but, you know, it's actually I'd like to put in a plug in for the Liberty Counsel. They're a group of aggressive Christian lawyers out of Florida that have helped open up and crack apart the false pandemic in California and opened up the churches again that Governor Newsom was closing down. So we have to be very grateful that our forefathers, our Christian forefathers, they had left a Bill of Rights for us to avoid what we're into but we have to exercise these rights, we have to get engaged as a culture.

Dr. Joseph Mercola. We have a real treat for you, probably one of the most important interviews I've ever done. Why? Because we're going to talk about something so unthinkable and shocking that you're likely going to be very surprised. That's why I've got Dr. Vladimir Zelenko. In my observation, clinicians who are committed, who have high integrity and committed to the truth of the fundamental basis of what solving the problem that their patients come to them with eventually come to the same conclusion even though they're coming from different backgrounds and perspectives and you're a classic example of that.

Dr. Vladimir Zelenko. I think there are so many solutions that are simple and based on millennia of information and the trend in the pharmaceutical industry and modern society

is to believe that something that is new or has a patent or is a brand name is better for you, and sometimes it is but sometimes it isn't and this is the perfect example where like COVID-19, we can call it death by affluence because a lot of the countries that could afford the vaccinations and the expensive treatments, they suppressed the cheap generic treatments in other countries that have had no choice. I remember I consulted, the government of Honduras consulted with me. It's a very poor country and they adopted the pre-hospital approach very early and even their President reported to President Trump that they were seeing tremendous results. So when I say death by affluence, it means that our own wealth, materialism and profit-driven desires sometimes end up killing us.

Mercola. Yes, indeed, not by design, well, actually by design but designed by people behind the scenes, as you clearly referenced earlier. So I really appreciate your framing this and putting it into proper perspective to give people an understanding, the proper understanding of what's happening so they can make informed decisions and really identify strategies that they're comfortable with and rather than listening to the incredible 24/7 propaganda they're being exposed to. It's just, it's crazy. I mean, you know, you refer to this as the genocidal event. I mean, it's literally, it most likely will be at least 5-10 times more deadly than what they did in World War II unless people get, wake up, and I don't think that's going to happen because the propaganda is so comprehensive.

Zelenko. Right. So this is a battle for the consciousness of man, whether we're going to, I'll get a little theological, whether we're going to accept that there's a God that we're made in his image and our lives have sanctity or whether we're going to submit to the idol worshipers and the corrupt human beings that really are looking to make themselves feel better about themselves and more powerful by suppressing us. I think that there's a lot of this narcissistic, sociopathic, want to be deity mentality by the "woke" global intellectuals that think that they know better and in my understanding, they have devolved into the most base, you know, primitive human beings that you can imagine by their rejection of the divine nature of humans.

So my advise to anyone, wherever you feel that fear is being induced, whoever is trying to scare you, "Oh, the Delta variant is coming! Oh, my God, we're all gonna die again!" You should know that they're a mouthpiece for evil and I would stay away from them as far as possible and just purge fear from your mentality and just do the right, take, do simple preventive measures and your life will be much more meaningful and safer and fulfilling.

Mercola. Yes, indeed. Yeah, I've come to the perspective that there's really only two emotions that are out there, the one that you mentioned which is fear which they've used is the most effective motivator activating that [unintelligible] brain, but the other emotion that counters that is love and certainly you're an example of what applying that is in this context and spreading truth and information so people can understand and really rescue themselves from this tyrannical intervention.

## White Coat Summit

Doctor. On the right hand side, this is what the spike protein, just the spike alone from the vaccine is doing to the mitochondria of your cells. That's the engine of your cells, that's what gives you energy, the power of your cells. Compare the left, the smooth, nice, put together, compare the right blown apart, fragmented. That's from the vaccine, not from the virus, from the vaccine.

Okay, so here's the human body. You can see the plethora of sites where we have these two receptors. Now think about it. I mentioned they tell us, "Oh gosh, the spike stays in your deltoid." It doesn't, it circulates and the Harvard study in 13 nurses, they showed it circulating for at least two weeks. A lot of people lack something called mRNA's, an enzyme that breaks down the RNA so it may be circulating for even longer.

Now you hear, "Oh gosh, they died, you know, just so long after the shot." So you know, it was two weeks, three weeks, Hank Aaron, whoever. You know what? That spike is circulating. They tried to pull the wool over our eyes and say, "Well, it couldn't have been the shot. We're too far out." Not if the toxin is still circulating. Not if the toxin is still circulating. The spike is the toxin.

Damage to the lungs like I mentioned. On the left hand side, healthy lung tissue, nice, spaced out. You see, as a pathologist here, we look at all these cells all day long. That's kind of fun. We're nerds this way. On the right hand side, see how much more purple and blue that is? That's all inflammation. Why? ACE2 receptors in that lung, spike binding to it, inflammatory response, immune system attacking your own body. Disease from the spike.

Disease from your own clot-shot investigational vaccine. They keep lying to the American public by calling it a vaccine. They keep taking the word "investigational" off. It's what they call it in the Emergency Authorization. They keep not calling it what it is, investigational, an experiment on humanity. And that's what they're doing and I'm showing you why. Spike is a toxin. It crosses the blood-brain barrier. I kind of like my brain cells to be where they are and not be blown apart, right? So why in the world would we put a toxin into the human body that's going to disrupt the blood vessels in your brain, allow the spike in there, will cause inflammation? The brain fog you hear about from the COVID patients, guess what? You hear about it in the post-vaccinated damaged individuals as well. But no, nobody's hurt by the shot and there's not been one death, there's not been one injury. That's what they tell you. It's a lie and this is science.

Okay, here we go. That's all the blue on top, those are brain cells. All the blue doesn't belong there. That's inflammation from the spike.

What about the kiddos' heart inflammation? Guess what? Lots of ACE2 receptors in the heart and here you can see on the left hand side, see those blue arrows around the white? That's inflammation in the heart. That's not normal. That's after a shot. That's a spike protein landing there. That's your immune system attacking your own tissues. Do you see on the right? That's the red arrows. That's the pericardium, the sac that surrounds your heart. That's inflammation. That doesn't belong there.

Once you have heart damage, the heart does not heal itself. Okay, left hand side, all the blue dots, inflammation. Do you see that gray in the middle? That's early scarring. Guess what? Once a heart cell is damaged, it's damaged forever. It doesn't replace itself with another heart cell, it replaces itself with a scar.

So you tell me you want to give a 12 year old, a 5 year old, a 13 year old, an 18 year old, a shot and we see about a 200 times increase in myocarditis in our society right now? That's a good idea. Let's give a kid a toxin, ruin his heart for life.

Stop and think about what we're doing. Insanity. We need to stop the insanity immediately. This is over. Game over. This is no longer good science. This is a poisonous attack on our population and it needs to stop now.

Kidney, same thing. Kidneys are kind of important. Three things in life: blood goes round and round, gotta breathe, gotta make pee. You don't do those three things, you die. Kidney. You want to damage your kidney with a clot-shot? Not a good idea either.

Liver. Kind of need your liver to detoxify everything in your life. Same thing. Damage to the liver. See all that blue? That's inflammation. It doesn't belong there.

Testes. Kind of important for the next generation, right? As much as that looks like a lovely heart, see all the blue in it? Inflammation.

The same thing in the ovaries. Here's the problem: essentially absent from the literature. What are they hiding from us, okay? Japanese biodistribution study, took some doing to find this study. Dr. Bridle(ph) up in Canada, of course, he was attacked for telling the truth. The lipid nanoparticle that surrounds the little mRNA they're injecting into people's bodies, yes, a lot of it stays in the deltoid but it circulates as well. Guess where it likes to concentrate? A really biologically active organ, the ovary. And in the Pfizer paperwork and application, it clearly states that in the rats there was a 16% decrease in fertility. One of the most fertile little critters, mammals on the planet and they, "These are not the droids you're looking for. Never mind."

So what's it doing to humanity? Guess what? The answer is: we don't know because we don't have long-term safety data yet. That's the tragedy and the crime in all of this. They're pushing it. It's an experiment. It's Emergency Authorized, it's not approved.

Humanity is the Phase III trial. COVID is a clotting disease, as some of my colleagues have mentioned. After a shot, we, as physicians, especially in patients complaining of

post-vaccine symptoms...a d-dimer will go up when we have clots. We can't see these clots on x-ray or scan, these are micro-clots. All these inflammatory patterns that I'm showing you are from micro-clots as well. If we look at this in the patients, we know that they're micro-clotting. So this is something Dr. N., just like Dr. E., mentioned, a patient who has already had COVID, COVID recovered, broad beautiful immunity, they're lying to you to say that it's not equal to a vaccine immunity. I love the blue-pen rainbow analogy Dr. E. gave, screen before vaccine. There is a multifold increase risk of adverse reactions if you've had COVID and are recovered, you get a shot, you hyper-activate that immune system, you may be screwed and/or dead.

All right, I'm going to reiterate: one cannot find that for which they do not look. Billions of dollars spent on advertising of, again, a toxin into the human body, investigational vaccines. Again, I will say to our agencies, our Federal government, where's the funding for real science? They don't want you to see what we're seeing. In the laboratory, I have the tissues of a dead man on the back of my desk. I have two more coming next week. Guess what? Just a couple of days after a shot. 50 year old, healthy triathlete. One of my favorite surgeons in town that I work with, second shot, mountain biking, gone.

All right, the other concern I already brought up, we have no long-term safety data. This is what we need to emphasize to society and ask the authoritative agencies, "What's the risk for cancer after this shot?" We don't know. "What's the risk for autoimmune disease?" We don't know. "What's the risk for impairing fertility for a lifetime?" We don't know. So why in the world would we willy-nilly push forward at the pace and the rate that we're going without knowing these things? Complete anti-science and a complete attack on us.

No more mandatory forcing of employees. How in the world are these hospitals and these employers saying, "You can't work for me if you don't sign up to be a subject in an experiment on humanity." Go back to the 1947 Nuremberg Code. We're absolutely violating this as a nation and a people.

Where are the billions to do the autopsies? Where are the billions to prove the science? Where are the autopsies? I will go back. Crickets. They're not there.

Dismissal by the collusive media of any adverse events or death. That's a problem.

And what happened to the concept of the me-too movement, believe everybody? What happened to believe her, believe the story? What happened to believe anyone? Why won't they believe the science? They won't believe the science, they dismiss the science. What happened to this movement of believe it until you can disprove it? Gone. Gone.

All right, a couple of side-by-side notes. Really critically, and I'm almost out of time, what we're seeing in the laboratory is the shots dysregulate your immune response. We have very important cells that keep other viruses in check, that keep cancers in check. There's a type of cell called a CD8 killer T cell. Well, there's a study out of Germany and the Netherlands that showed a shifted immune profile, and at the end their conclusion

was, "We see a concerning pattern of the cells we normally need to fight off these other things, but the answer is we don't know for how long that shifted pattern lasts." It's like having eight blockers on the front line, this is Texas, we can talk football, having eight blockers on the front line and paralyzing three or four of them, but the answer is we don't know if they're paralyzed for the rest of the game or the rest of their career.

And then what we see from this in the laboratory is an uptick of herpes family viruses, malloscum, human papillomavirus, all sorts of viruses, mononucleosis, etc. reactivating, reactivating at levels and I'm a pathologist so we see this in the laboratory and I'm seeing the early signal. Well, guess what else that CD8 cell does and some receptors on some of these T cells called toll-like receptors and there's a certain pattern of them? They keep cancer in check. I have seen a 10-20 fold increase of uterine cancer in the last six months in my laboratory and I keep data year to year to year. In the last six months. When did we start the shots? January.

How much solid tumor cancer increase are we going to see over the next several years? Probably a lot. What's the real answer? We don't know and sometimes that's the most honest answer in medicine is we don't know. A doctor that tells you he or she knows everything, don't believe them. Find a new doctor.

Increase of latent viruses, etc. etc. So anyway, I know I'm out of time for questions. Thank you so much and God bless.
