Hi again. Debate format would be roughly as follows:

1. Each side gets 5 minutes uninterrupted opening statement.
2. Each side gets 3 minutes uninterrupted response statement.
3. Each side gets 5 minute uninterrupted question phase.
4. Each side gets 5 minute uninterrupted response to question phase.
5. Each side gets 5 minutes questions based upon answers phase (similar to redirect)
6. Each side gets 5 minutes to respond.
7. Closing arguments.

Ok. After really contemplating it, I believe you have 3 main errors:

1. I believe you are commingling the terms 'word of God' and Scripture to mean the same thing; when they are not the same thing.
2. I believe there is a false balance to your argument; an overemphasis on Scripture vs. relationship to The Lord Jesus Christ, plus an overemphasis on Psalm 12. And I don't believe your interpretation of Psalm 12 is correct.
3. (the one that I have an issue with) There are too many ad hominem attacks and too many strawmen arguments in your sermons on those that believe other than what you do.

I've tried to provide a good faith answer to your questions, at least in a general sense. Can we get you scheduled for the first week in November?
