Biblical Eugenics Pt. 3: "Abortion: Murder Most Foul!"

I Text:

Old Covenant: *Exodus 1:8-22*

New Covenant: *Romans 1*

II Doctrine: The field of Eugenics is a humanistic corruption of God's dominion mandate. The Pharaoh of Egypt, Plato, and Bill Gates Sr. all believed in playing God and asserting their own form of Eugenics. Pharaoh is the archetype of metaphysical rebellion as he declares himself God. Pharaoh now enthroned in his mind as god, declares himself the source of epistemological reality. The perverted epistemological reality Pharaoh has established, leads to a perverted ethic. The Western Church has led the collapse of society by embracing egalitarian humanism. The United States of America ceased to be a viable nation in 1973 when it began to murder its own children. Covenant keeping Christians should be preparing for the continuity of a Godly people in the midst of this collapse

III Comparing Scripture With Scripture:

1) The field of Eugenics is a humanistic corruption of God's dominion mandate. The Pharaoh of Egypt, Plato, and Bill Gates Sr. all believed in playing God and asserting their own form of Eugenics. (*Exodus 1:8-22*)

2) Pharaoh is the archetype of metaphysical rebellion as he declares himself God. (*Exodus 5:1-5; Romans 1:20-23*)

3) Pharaoh now enthroned in his mind as god, declares himself the source of epistemological reality. (*Exodus 5:6-14; Romans 1:24-27*)

4) The perverted epistemological reality Pharaoh has established, leads to a perverted ethic. (*Exodus 12:29-31; 14:5-9; Romans 1:28-32*)

5) The Western Church has led the collapse of society by embracing egalitarian humanism. The United States of America ceased to be a viable nation in 1973 when it began to murder its own children. Covenant keeping Christians should be preparing for the continuity of a Godly people in the midst of this collapse. Definitions:

1. Definition of metaphysics

1a (1): a division of philosophy that is concerned with the fundamental nature of reality and being and that includes ontology, cosmology, and often epistemology

2. Definition of epistemology

: the study or a theory of the nature and grounds of knowledge especially with reference to its limits and validity

3. Definition of ethics

1 ethics plural in form but singular or plural in construction: the discipline dealing with what is good and bad and with moral duty and obligation

2 a: a set of moral principles : a theory or system of moral values
the present-day materialistic ethic

4. Definition of ontology

1: a branch of metaphysics concerned with the nature and relations of being

Ontology deals with abstract entities.

2: a particular theory about the nature of being or the kinds of things that have existence

5. Definition of eugenics

: the practice or advocacy of controlled selective breeding of human populations (as by sterilization) to improve the population's genetic composition
