NAZI-DEATH CULTURE ARISING (Part 1)
(HOSPICE HELL)

Before we take a look at the alarming spread of the culture of death, let us notice what the Holy Bible teaches us about life. We should choose life (Deuteronomy 30:19). But the evolutionists who have embraced population-control, etc. believe in euthanasia, or so-called "mercy killing." It is the same worldview that tries to justify abortion; and it is being expanding to include the elderly, the sick, etc:

2 Timothy 3:1 This know also, that in the last days **perilous times shall come.**

2 For men shall be **lovers of their own selves...**

3 Without natural affection...

5 Having a form of godliness...

The Bible condemns euthanasia as murder. An Amalekite was given the death-penalty for professing to euthanize Saul:

2 Samuel 1:8 And he said unto me, Who art thou? And I answered him, I am an Amalekite.

9 He said unto me again, Stand, I pray thee, upon me, and slay me: **for anguish is come upon me, because my life is yet whole in me.**

10 So I stood upon him, and slew him, **because I was sure that he could not live after that he was fallen...**

15 And David called one of the young men, and said, **Go near, and fall upon him. And he smote him that he died.**

When Job felt as though he would rather die, his friends who sat at his side did not grant his desperate desire:

Job 7:15 So that my soul chooseth strangling, and death rather than my life.

Nabal was in a paralyzed state; yet Abigail did not smother him, etc., to put him out of his misery:

1 Samuel 25:37 But it came to pass in the morning, when the wine was gone out of Nabal, and his wife had told him these things, that his heart died within him, and **he became as a stone.**

38 And it came to pass **about ten days after**, that **the LORD smote Nabal, that he died.**

Mephibosheth was lame on his feet, and he referred to himself as a "dead dog"; yet David had him sit at his table, in kindness to Jonathan. As for the insane, even the Philistine king did not euthanize David when he thought he was mad. And even the cruel Babylonians permitted Nebuchadnezzar to live when he went mad. The Bible warns that violence and murder will fill the earth in the final days before the coming of Christ (Matthew 24:37, Genesis 6:11, Revelation 9:21). But will it be called *murder...or mercy?* (Remember that the local abortion/murder clinic is called, "Whole Woman's *Health*"!)

MURDER BY MORPHINE

Today, a common form of euthanasia is murder by morphine. Instead of using a pillow to smother a person, the victim's respiration, etc., is shut down by the drug:

2 Kings 8:15 And it came to pass on the morrow, that he took a thick cloth, and dipped it in water, and spread it on his face, so that he died...

Notice the dangers of morphine:

"...morphine death occurs from **paralysis of the respiratory** center...In morphine poisoning **diminution [lowering] of the blood pressure** plays an important part..."

(*Scientific American*, 1889)

"...little quantitative information on the morphine problem has been gathered with man as the subject...Time and again reference is made to a **slow respiratory rate** after the administration of morphine...toxic doses of morphine may cause a **fatal interference** in the respiration...**therapeutic doses of morphine may induce extreme respiratory depression** in certain sick individuals..."

(R. H. Manske, *Pharmacology*, 1965)

"The sedative effects which opium or morphine exert upon the respiratory system should certainly contra-indicate their employment in cases in which respiratory embarrassment or failure would be likely to occur...In illustration of this may be cited the following remarkable case in which it seemed probable that the **cessation of breathing** which occurred was **partly or wholly to be attributed to morphine** thus administered. The patient was a young woman who presented unmistakable symptoms of a cerebral tumor...A hypodermic injection of morphine was given...As the operation proceeded **respiration became more and more feeble and then ceased**. It was restored by artificial means, but again ceased and was again restored. One hour and a quarter after the commencement of the operation it ceased for the third time and could not be made to return...the patient died."

(*The American Practitioner*, 1887)

In spite of these basic facts, morphine (or a similar drug) is commonly given to sick people. And when the respiration shuts down, it is then claimed that the person died of their sickness.

[Testimony of my aunt's death with Hospice - watching the hospice "nurse" continue to suggest more morphine for my aunt, who was already being starved and dehydrated. The extra dose finally stopped her breathing.]

After watching this terrible situation unfold, I immediately determined that thousands of people are being murdered by morphine, and that for those who are discerning enough to realize what is happening, they are being pressured (and programmed) to be quiet on the basis that this is all very "merciful" (as is claimed about abortion). When looking online in my hotel room the night of my aunt's death, I was not surprised to find a whole movement attempting to break through the media censorship, and expose this new holocaust of murder by morphine. Man is playing God!

The day I arrived back in town, the first words a street-preacher acquaintance said to me, in downtown Fort Worth, was, "Hospice is killing people. It is involuntary euthanasia. Morphine shuts down the respiration." In a state of shock, I asked him to repeat these words! I then told him what I had found, and of our own experience with this tragedy, just a few days earlier. Here is an excerpt from this man's latest newsletter:

"*Dr. Death's Dream*...Kevorkian's obsession with death could be seen in his oil paintings. His work leaned toward the grotesque...Jack Kevorkian is now dead, but his 'dream'...has become a reality...Prior to my dad's death, I started hearing horror stories concerning hospice care which reaffirmed [that] I made the right decision concerning my dad...There are endless stories across America...Dr. Death's dream has come true!...That is why most patients who sign up for hospice only live for four or five days. Family members usually watch in horror as their loved one gasps for breath..."

Hospice workers are either knowingly participating in the deception (believing in the euthanasia philosophy), or else others are simply deceived by their training-propaganda. Notice the following deceptive propaganda that hospice workers are indoctrinated to embrace:

"Morphine is one of many drugs that is used to treat moderate to severe pain...In hospice medicine we use it all the time...There is the thought in the medical community (outside of hospice) that morphine causes respiratory depression and that this phenomenon is always bad...What I've seen over and over again is that **it works**. It's amazing what it does for a person's **quality of life**. But despite the research and what hospice professionals know, **I can't tell you how many times I've heard '...oh no, we can't treat shortness of breath with morphine, it causes respiratory depression...'**...[Try it.] You have **nothing** to lose **but the suffering**."

Patients are often sedated into unconsciousness and then starved to death (or dehydrated). When they begin to show signs of suffering from their starvation, etc., they are given dangerous doses of morphine, that stops the breathing.

This is commonly justified by claiming that so-called "terminal" patients would want things this way. Yet, *The Lancet* (June 29, 1996) found that such patients in a seemingly, hopeless situation, with significant pain, were more opposed to euthanasia than the general public!

Proverbs 24:7 Wisdom is too high for a fool: **he openeth not his mouth in the gate.**

One whistleblower, Ron Panzer, a nurse, is working hard to expose this tyranny. After witnessing serious violations in standards of care by a Michigan hospice, he founded the Hospice Patients Alliance (<http://www.hospicepatients.org/>). In an e-mail to me, he writes:

"Yes, [morphine, etc.] slows the breathing, drops the blood pressure, sedates into a coma, if too much given or not needed, and stops breathing (kills)...The lies are terrible. In only rare cases does it help, for example end stage heart failure with pulmonary edema...However, if no diuretic is given, then you know they are lying about it. Yes, it 'relaxes' so the patient is 'comfortable' as they are killed...You can use whatever you wish to...It was written to serve Him and the people."

He has written a book titled, *Stealth Euthanasia: Health Care Tyranny in America*, 2011 (<http://www.hospicepatients.org/this-thing-called-hospice.html>). In this book, Panzer writes:

"This book contains the most-censored story in America, and we cannot guarantee that this information will be available in the future...It offers a rare glimpse from my experience within the end-of-life industry, my work as a patient advocate, and includes the revelations of hundreds and hundreds of people as they have recounted it to me...I have many friends within the hospice industry who confirm what I recount here in this book...This is the story of the intentionally 'below-the-radar' changes that have been aggressively pursued in our society for decades. Because these changes are not covered by the major media in any coherent, connected way, or at all, **the public has difficulty 'putting a finger' on what is happening and why**...they do not arise from American Constitutional values...It's been coming for over seventy years. Americans have been quietly 'asleep' while those who have made war on American values achieved success after success...When family members recount what hospice staff said to them, the language and phrases used sometimes are exactly the same, the actions taken exactly the same, the outcome exactly the same. The reason? The staff at different agencies across the country are being trained in the same way...*the Euthanasia Society is connected with the largest segment of the hospice industry in America*...the largest hospice organization in our nation is the successor organization to the Euthanasia Society of America...many hospices in the United States today have no reservations about hastening death through a method called 'terminal sedation'...some hospices may go years without being inspected... nobody interested in researching what is actually going on in hospice can get access to the data, so hospices that have an agenda can act without any outside interference...This is how Robin Love's father who was not terminal was hauled off to hospice, deprived of food and water and was given large doses of morphine and sedatives. He died shortly thereafter....What the public thinks about hospice is a carefully constructed image...You could say that our society has been manipulated, maneuvered, even 'conditioned' to think in ways that are completely contrary to the way Americans thought for the past two centuries. And millions and millions of dollars have been spent to achieve this...many people have adopted the 'quality of life' ethic where it's 'ok' to end someone's life because they are 'seriously disabled,' 'very elderly,' have dementia or any number of other reasons. In a very real sense, many of us have become numb to the killings...If there were no medical murders, books

like *Caring To Death: A Discursive Analysis of Nurses who Murder Patients* (by John Field, PhD; where over 50 cases of nurse killers from around the world are discussed) would not be written. That book is about the sensational cases that leaked out into the media and the killer nurses were apprehended and convicted...[But with] stealth euthanasia, policymakers, nurses, doctors and others, whose actions or decisions cause death, are not apprehended and they certainly are not prosecuted... magazine articles promote hospice as the 'other way' to make someone die on demand...we have reports that when families refuse to go along, hospital staff do use the social service agencies to get their way [even with the elderly]...Hospital staff may intimidate family members into signing a Do-Not-Resuscitate order and then put their loved one into hospice. It happens every day...There are reams of documents detailing the abuse, neglect and harm being done to these very elderly and the disabled, but no marches...No justice...It as if our society is 'lynching the elderly and disabled' and nobody comes to rescue them...In the United Kingdom, Dr. Howard Martin stated on February 11, 2011 that, 'giving morphine to terminally-ill patients in hospital to end their lives was a regular occurrence'...'Hospice is a philosophy!' exclaim some websites (run by hospice business entities)...I can tell you that for about thirty years it's been a business! It's corporate! And it's big, getting bigger every year!...In many cases, family members have even been banned from being at their own mother's or father's side (or other family members' side), simply because they objected to the patient receiving an overdose of morphine or other un-needed medications...In many cases, the Adult Protective Service system is even used to intimidate those who truly care about the patient and object to clinically unnecessary or harmful interventions...the top administrators at many big hospice businesses are paid hundreds of thousands of dollars each year...Even though hospice corporations take in donations, they are funded mostly by the federal government's Medicare and state Medicaid programs...Why would the federal government do that? Because 'hospice' saves big bucks over acute hospital care...if you know any other industry where the funding is increasing by \$1 billion each year, let me know. The federal government obviously has big plans for hospice and its future role in the American health care system and in your life and your family's lives...With the baby-boomers moving into the elderly category, more and more of them are developing acute and chronic conditions...Hastening death at the end-of-life is done in many ways, and deception is often used...Other methods of hastening death include giving medications that are not needed...The elderly may never recover from these adverse effects and then be labeled 'dementia' patients. Overdose symptoms may include extreme drowsiness, confusion, muscle weakness, fainting, or coma...In Nazi Germany, the Nazis began to implement their eugenics and extermination program by executing the frail, the mentally ill, the terminally ill and other chronically ill by order of the federal German government...[evolution's death philosophy]...[Psyche] drugs cause death in dementia patients and [yet] they are given to dementia patients... stealth euthanasia!...today's records of those victimized by stealth euthanasia are always falsified to reflect a natural death...Morphine overdose or terminal sedation is almost never listed as the cause of death...Yes, you can prove that the doses of morphine [were too large]...The problem? The hospice agency will hire two or ten physicians who swear just the opposite...Today, the justification is given that it's all being done for the good of the suffering patient. Guess what? The Nazis did use exactly that language!...One hospice volunteer with twenty years'

experience called me in tears a while back. She had started working at a new hospice home and every patient was sleeping continuously...It was terminal sedation...Right-to-life groups act as if they are totally 'in the dark' when it comes to the realities of the end-of-life care industry!...Families report over-hearing conversations between two hospice nurses (who thought no family member was there to listen): 'the nurse said, 'I'm just like Jack Kevorkian, but I do it with morphine and get away with it'...I can't tell how many times through the years family members will call and tell me how their loved one was overdosed with morphine. Often, they report that the hospice nurse will tell them, 'Morphine helps the breathing.' That specific line is repeated over and over again, all across the country, so I know the staff are being trained to believe this."

Proverbs 24:12 If thou sayest, **Behold, we knew it not**; doth not he that pondereth the heart consider it?...

The HPA website reports:

"...These are actual letters received from families all over the nation...deaths are commonly covered up through false charting in the medical record. For example, a patient who receives massive dosages of morphine and who has NO pain, has in his chart 'Patient complaining of pain,' when there was no pain before, during or after receiving the morphine...Kaiser Health Plan instructs its patients and nurses that morphine helps breathing...Charles Phillips, MD, patient advocate and former Kaiser Permanente physician, comments...'Morphine is like a loaded gun which is so powerful that it can kill a patient by lowering their blood pressure and stopping the breathing'...Morphine slows down the breathing. It does not increase the respiratory effort at all...Not only does it sedate, in large doses, or doses that are not needed, it shuts breathing down completely and can cause death. **And conveniently for those who wish to hasten death, the signs of morphine overdose are the same as some of the signs of imminent death:** sharply decreased blood pressure and much slower breathing, sometimes stopping at times...**Those nurses who have been mis-educated to believe that morphine is the 'solution' for breathing problems see the outward signs of the morphine overdose, but interpret them as showing the patient is dying. They believe in what they've been taught and give morphine freely for breathing!**... if the patient dies, the family and staff are led to believe the patient died of their illness, not the morphine (that is the last thing the hospice or Kaiser wants them to believe)...I recently received vitriolic emails from just such a mis-educated hospice nurse. 'Stephen M,' a Registered Nurse with special certification in Palliative Care who works in a hospice wrote to Hospice Patients Alliance on November 29, 2010:

'Morphine is not what kills people you morons. It is their time to go and god takes them when he is ready...You or anyone could drink the entire Roxanol (liquid morphine) bottle which had 30ml in it. That is a large amount and you would not DIE!'

That, from a certified hospice professional!...The maker of morphine states:

'Acute overdosage with morphine is manifested by respiratory depression...stupor or coma...hypotension and death'

Where did Stephen M, RN, get his ideas? From hospice management...They promote this type of misinformation which all tends toward hastening the death of the patient...There is a reason the major media refuses to publish the truth about hospice, palliative care, health care reform and stealth euthanasia. Most of the major media outlets like the Washington Post, ABC News, CNN and others have direct connections to those who support the culture of death approach: George Soros and others. Soros has poured millions into the major media...

...I've had calls from families whose loved one was found upon autopsy to never have had any cancer. They were placed in hospice because a surgeon told them the patient had 'inoperable cancer'...The cause of death listed on the death certificate? 'Lung cancer' or something like that. The real cause of death? Hospice care...

[Government loves hospice; the media loves hospice; hospitals love hospice...] Greedy children or spouses who can't wait to get their hands on the money, the house, the estate....love hospice!...

Caller: 'My sister killed my father by using hospice!' That from a trained Registered Nurse with two decades of experience...Family members are afraid to speak out...They don't want to cause an irreversible rift in the family...It is a very strange thing to witness the victims being afraid to speak out against the killers...

[Notice a letter]:

'My mother was recently a hospice patient...while under hospice care she died of 'acute morphine intoxication.' This has been confirmed by an autopsy...and now is being investigated by the county D.A....I know that this is not an isolated case...What I find particularly disturbing is that my mother did not want to take the Roxanal (liquid morphine), and that's what caused her death...The hospice nurses kept insisting that **it would help her breathe**, although everything we read stated that morphine (made from opium) would actually slow down her breathing and could even stop it completely...my brother and myself were encouraging [my mother] to [take it] **based on what the hospice kept telling us**. We trusted them!...The day before her death, the hospice nurse came into our home, and said that the attending physician said my mom could have 20mg of the roxanol, every 2 hours. That was 4 times the amount we had been giving her...her breathing was still labored...the nurse administered the larger dose...The last thing I remember my mom ever saying was 'but I just had some'...The following morning...[with my mom now in a coma], the hospice nurse returned. She insisted that my mom **needed** some more roxanol. My mother's **breathing rate had slowed down considerably** and I vehemently said 'no,' telling the nurse that I still felt as though the morphine had caused the coma. She denied...She said my mom was **actively dying**. It had nothing to do with the morphine. The nurse told me it was

'inhumane' to allow her to struggle for breath as she was. The morphine would **only help** to make her breathing **easier**...my mom died later that evening. Now I know that the morphine killed my mom."

The hospice way of ending life is called the *Third Way*. It openly admits that it does not try to lengthen (preserve) life!:

"Hospice care is humane and compassionate care, and **it does not slow down** or speed up the end of life."

However, even this admission is a lie, since often "lethal medication" is used to get around the laws prohibiting euthanasia/assisted suicide:

*"Protect your family from the invisible holocaust...Lonely and abandoned...patients exhibit blank, ghoulish stares reminiscent of concentration camp victims. If they will not die soon enough, some nursing homes even call in hospice workers to facilitate premature death. Many residents experience hospice at its most lethal, receiving no food or fluids, increasing dosages of morphine and sedatives, until a patient's life is snuffed out...politicians know that dead citizens no longer require Social Security, Medicare, Medicaid, hospital care or other services...Hospices are reimbursed for each day a patient is enrolled, but there is a cap on reimbursement. **When the cap is reached, the hospice loses money every day the patient continues to live**...We cannot learn how many patients are killed because medical records are private and healthcare workers are forbidden from discussing their patients...Our system's ability to create a private death camp in any healthcare bed is...sinister genius at work...I have spoken to major media reporters about these cases many times, but their managers refuse to expose it because they embrace the secular agenda and euthanasia...American doctors and nurses no longer wear the all-white uniforms that were a symbol of their pure intentions and a sign that we could wholeheartedly trust them to care. This invisible holocaust isn't a future possibility; it is now, so do everything in your power to protect yourself and your loved ones."*
